EDGAR FILINGS

Tuesday, February 16

Deadline for filing Schedule 13G; Form 5 with respect to issuers with a December 31 fiscal year end; and 13F for filers with quarter ending December 31, 2009

Monday, March 1

Large Accelerated Filers – 10-K Deadline for those with fiscal year end of December 31, 2009 (60 days after period end)

Tuesday, March 16

Accelerated Filers – 10-K deadline for those with fiscal year end of December 31, 2009 (75 days after period end)

Wednesday, March 31

Non-Accelerated Filers – 10-K deadline for those with fiscal year end of December 31, 2009 (90 days after period end)

Monday, May 10

Large Accelerated & Accelerated Filers – 10-Q filing deadline for quarter ending March 31, 2010 (40 days after period end)

Monday, May 17

Non-Accelerated Filers & 13F Filers – 10-Q and 13F filing deadline for quarter ending March 31, 2010 (45 days after period end)

Wednesday, June 30

International Filers – deadline for filing form 20-F or 40-F for firms with December 31, 2009 fiscal year ends

Monday, August 9

Large Accelerated & Accelerated Filers – 10-Q filing deadline for quarter ending June 30, 2010 (40 days after period end)

Monday, August 16

Non-Accelerated Filers & 13F Filers – 10-Q and 13F filing deadline for quarter ending June 30, 2010 (45 days after period end)

Tuesday, November 9

Large Accelerated & Accelerated Filers – 10-Q filing deadline for quarter ending September 30, 2010 (40 days after period end)

Monday, November 15

Non-Accelerated Filers & 13F Filers – 10-Q and 13F filing deadline for quarter ending September 30, 2010 (45 days after period end)

Friday, April 30

Annual Financial Statements are due for companies with fiscal year ending December 31 (120 days after year end)

Sunday, May 30

1st quarter reports are due for companies with the fiscal year end of December 31 (60 days after quarter end)

Sunday, August 29

2nd quarter reports are due for companies with the fiscal year end of December 31 (60 days after quarter end)

Monday, November 29

3rd quarter reports are due for companies with the fiscal year end of December 31 (60 days after quarter end)

Non-Venture Issuers

Wednesday, March 31

Annual Financial Statements are due for companies with the fiscal year ending December 31 (90 days after year end)

Saturday, May 15

1st quarter reports are due for companies with the fiscal year end of December 31 (45 days after quarter end)

Saturday, August 14

2nd quarter reports are due for companies with the fiscal year end of December 31 (45 days after quarter end)

Sunday, November 14

3rd quarter reports are due for companies with the fiscal year end of December 31 (45 days after quarter end)
